9.	Divisional Soil Conservation Officer Department of Soil and Water Conservation	Member
10.	Executive Officers of Municipal Committees	Member
11.	Executive Engineer, Punjab Pollution Control Board	Member
12.	Any Other Member nominated by the Chairperson	

2. The Punjab Water Regulation and Development Authority (PWRDA) is in the process to issue its Punjab Directions for Groundwater Extraction and Conservation, 2022. The Committee shall work in order to implement and monitor the Directions issued by the Authority.

3. The DICWRD may conduct monthly meetings and send its minutes to the Government (Department of Water Resources) and to the Authority. The Authority shall review the progress of DICWRD's from time to time and issue such orders to the DICWRD as may be required to ensure the implementation of its Directions and to achieve the objectives and purposes of the Act.
