	NIC has professed its reluctance to develop a Billing Software for the Authority. Even though their proposal for development of modules other than Billing was principally accepted, no further communication has been received from them in this regard. Moreover in this proposal the NIC has given a long timeline of 10 to 12 months for development of only the Permission Module. Given the urgent requirement of Software HDFC and ICICI banks have offered to facilitate the development of the required software in a short time span. After seeing the presentations on the initial proposals from both the banks, it was felt that HDFC Bank would be able to provide better services in regard to the requirements on the Authority. The bank has submitted a draft Memorandum Of Understanding (MoU) which is to be signed between the Bank and the Authority. Officials of the Bank have assured that within 3 months they will get the software ready. For development of this software no cost will be borne by the Authority but the Authority will be required to keep the Saving account of the Fund with HDFC Bank. Even presently this account is already with HDFC Bank. The MoU (Annexure-A2) is placed
