Item No.34.01:- Regarding appointment of Technical Advisor:

- A) In its 33rd meeting, the Authority decided to re-designate one post of Technical Expert out of the four sanctioned posts of Technical Expert as Technical Advisor, with a monthly remuneration of Rs 1 Lakh to 1.10 Lakh. The essential qualification for this post was decided as under:-
- 1. Bachelor's degree in Geology/Hydrogeology/Agricultural Engineering
- 2. Master's degree in any branch related to the above-said subjects.
- 3. At least 20 years experience in the field of water management preferably Groundwater.
- 4. At least 5 years of administrative experience in Government Department related to water management and conservation.
- B) In view of the decision of the Authority, applications were invited through public notice in the press and on the website of the Authority. Last date for submission of the applications was 28.12.2021. By the last date only one application has been received from Shri Rajesh Vashisht.
- C) The concerned branch in the office has examined the application and has found it to be in order. ADO has also reported that the applicant fulfills the qualifications/experience advertised for the post. The details of the education qualifications are as under:

Submitted for consideration.

Decision: Authority observed as under:-

1. Since there is only one candidate hence the post should be re-advertised giving 15 days notice. The candidates who have applied earlier need not to apply again.

- 2. Besides giving advertisement in the Punjabi Tribune, Hindustan Times, Dainik Bhaskar (Chandigarh and Punjab), the post should also be advertised in the Employment News. Emails may also be sent about the invitation of applications to PAU, HAU HPAU, IARI, G.B. Pant University of Agriculture, CGWA and National Institute of Hydrology, Roorkee and such other institutions.
- 3. Essential Qualification: In the essential qualification the following should be added:-Bachelor degree in Agriculture/Environmental Sciences/Environmental Engineering.
- 4. Desirable Qualification: In the desirable qualification in point number 2 modification may be made to provide the requirement for knowledge of surface and groundwater resources instead of surface and groundwater resources in the state of Punjab & point number 3 may be deleted regarding Knowledge of Punjab agriculture especially in relation to water availability.

With the permission of Chair the following item was taken up as table agenda:-

Item No. 34.02:- Regarding Selection of Technical Manager (Groundwater)

Applications were invited for filling up one post of Technical Manager (Groundwater) and various other posts vide advertisement dated 13.10.2021 with Gross Monthly Emoluments of Rs. 70,000/-. The final date of submission of applications was 29.10.2021. As reported by the office, 14 applications were received for this post till end of last date. All the applications were received via email in the Office.

- A. As per the Advertisement the qualification/experience required by the Candidate are:-
 - "1) Post-graduate Degree in Geology/ Applied Geology/ Hydrogeology/ Groundwater/ Earth Science/ Geo-Science from a recognized University/ Institute, and
 - 2) Minimum five years' working experience in the field of Groundwater/Hydrogeology as on the closing date for application. (Work done as JRF/SRF after obtaining essential qualification shall count towards experience)."
- **B.** The indicative Roles and Functions required are:-
 - "a. Collection of data in field including field surveys.
 - b. Collection and Collation of existing data of groundwater and related domains from various sources, its digitisation.
 - c. Entering data in relevant software such as ArcGIS, GEMS etc
 - d. Capturing data through GPS tools in field. Preparation of GIS datasets of the collected data Desk-based data capture (digitising) to convert paper maps to GIS datasets
 - e. Providing assistance in integration, analysis and interpretation of data

- f. Preparation of various thematic maps, litho logical sections, block diagrams etc
- g. Assessment of groundwater resources at various scales and boundaries.
- h. Communication with stakeholders.
- i. Any other work which may be assigned."
- C. In view of the decision of the Authority taken in its meeting held on 10.11.2021, a Committee of Secretary, Senior Manager (Admin & Coordination) and Executive Engineer held a meeting on 23.11.2021 to shortlist the candidates for the single post of Technical Manager (Groundwater).

Note: As per advertisement minimum 5 years experience in the field of groundwater/hydrogeology is required. Some candidates have completed their PHD and are having experience as scholar, so their time period as scholar may be considered as experience required. Therefore, out of 14 applicants, only 7 candidates namely, Ramanpreet Kaur, Salman Ahmad, Shamshaad Ahmed, Ritesh Verma, Sukant Kumar Abrol, Pintu Prusty & Ujjal Mal are found eligible for the post. Remaining candidates are not suitable due to remarks mentioned in column 8. Thus, the committee may considered above candidates for further selection.

E. Findings of the Committee: -

1. The committee examined the bio data of all candidates. As reported by the Office, only Seven applicants at Sr. no 1, 3, 4, 8, 9,10 and 12 have been found to be eligible. While deciding the eligibility of these candidates the office has stated that:

"As per advertisement minimum 5 years' experience in the field of groundwater/hydrogeology is required. Some candidates have completed their PHD and are having experience as scholar, so their time period as scholar may be considered as experience required. Therefore, out of 14 applicants, only 7 candidates namely, Ramanpreet Kaur, Salman Ahmad, Shamshaad Ahmed, Ritesh Verma, Sukant Kumar Abrol, Pintu Prusty & Ujjal Mal are found eligible for the post."

The committee agrees with this finding.

- **2.** Candidates at Sr no. 2 and 11 are not eligible as they do not fulfil the requisite experience criteria.
- **3.** Candidates at Sr No. 5, 6, 7, 13 and 14 are not eligible as their Post Graduate degree is not in the relevant field.
- **4.** In order to shortlist 3 suitable candidates from the list of candidates eligible for this post a grading criteria as detailed below has been formulated:

- a. 20 % Weightage for Marks Obtained in Post Graduation (Maximum Marks 20 marks)
- b. 5 Marks if the candidate has completed PhD.
- c. Maximum 10 marks for experience:
 - i. *One Mark* allotted for each completed year of relevant experience as required for the post.
- d. 5 Marks for Experience of Working on Geographic Information System (GIS)

Hence the candidates are to be allotted marks out of Maximum Marks of 40.

It is the Committee's considered view that after considering the order of merit as detailed in Table 2 above and all aspects concerning the candidates' suitability for the post, the committee shortlists the following three candidates one of whom may be considered by the Authority for appointment as Technical Manager (Groundwater):-
 - Dr Ujjal Mal.
 - Dr Salman Ahmad.
 - Dr Pintu Prusty

Authority is requested to take a decision on the matter.

Decision: After going through the report of committee constituted for short listing the candidates for the post, the Authority observed as under:-

- a. The Committee was directed to review the marks awarded to experience and educational qualifications in accordance with the conditions contained in the advertisement for the post in consultation with both the Members & recast its recommendations.
- b. Since no application has been received for the post of Technical Manager (Agriculture), the same may be re advertised in the newspapers as done earlier. The post should also be advertised in the Employment News. Emails may also be sent about the invitation of applications to PAU, HAU HPAU, IARI, G.B. Pant University of Agriculture and such other institutions
- c. The Authority noted that one post of Senior Manager (IT) advertisement for which was given on 16/12/2021, only two applications have been received till last date of submission of application i.e. 28/12/2021. The Authority directed these applications may be scrutinized soon & be put up to the Authority.
